How to Order & Pay

- The customer, by completing the our customer form will automatically agree with Smart Cherry Mobiles Ltd Terms and Conditions.
- Once the Proforma Invoice has been confirmed, the customer accepts this as a binding document between Smart Cherry Mobiles Ltd and the customer.
 All prices quoted are agreed once the proforma invoice has been sent.
- All prices quoted are subject to change, without notice; at any time should the
 proforma invoice not be paid within 3 working days of being sent. Goods will not
 be held more than 3 working days and can be released for resale after this period.
- All Payment's are required in advance of shipping via BACS to the nominated account.
- Smart Cherry Mobiles Ltd only accepts payments via bank transfer. We do not accept cash payments .
- Goods will not be released until full payment is confirmed and cleared funds are in the nominated account.
- Customers will need to provide proof of VAT certificate when in EU (European Union). Vat Reverse stock can only be sold to customers with a valid Vat number.
- Customer will be required to provide proof of ID and Address.

Grading Descriptions

GRADE A

- Grade A is a device in very good condition with minimal wear to the screen, back cover or chassis.
- There will not be any indentations or scratches of any kind.

GRADE B

• Grade B is a phone in used but good condition, cosmetically the phone will show signs of use, including some minor scratches to the screen and casing or equivalent.

GRADE C

- Grade C handset can show heavy wear, including deep scratches.
- Cosmetically the phone will show signs of use, including some scratches and scuffs to the screen and casing. It won't have cracks on the screen or casing.

GRADE ABC MIX

- Fully functional/ fully tested
- No cracks/smashes
- Can have wear and tear
- Will be a mixture of the above, percentage of A or B in mix is not guaranteed

No Smashes or Cracks on Any Phone.

Cannot return on cosmetic issues, only if a fault occurs.

- No Activation Lock/iCloud Lock
- WiFi Functional (Apple only)



Returns

We accept returns for the following reasons:

- Software faults
- Speaker faults
- Microphone faults
- Touch ID
- Network lock If sold as unlocked
- Incorrect model
- Incorrect Grade
- LCD Faulty

In order for any returns to be accepted, you need fill a RMA form within 14 days of the invoice date. Some handsets have 30/45 days returns policy, in which case you will have 30/45 days to report the fault. Failure to report the fault within the period stated above will result in refusal of return.

RMA form must be fully completed and sent to Returns@SmartCellular.co.uk. Once we have received your form and we will email you back with an acceptance email of handset which adheres to the above.

All handsets must be received in our warehouse within 14 days of receiving acceptance email to return the goods. Any handsets received out with this timeframe will be rejected and sent back to you.

No returns should be sent to us without being approved or without a copy of the approved RMA form. Handsets that arrive which have not been approved will be shipped back to the sender and no credit will be awarded.

Should your handsets be tested and no faults are found, the product will be returned to you with your next order.



Delivery

- Goods are safely packed for road or air transport. They are packed in 50 or 100 cell boxes. All boxes are labelled according to UN3481 with a lithium ion battery label.
- A packing list will be supplied (site dependant) in the box confirming each IMEI number and barcode.
